Code of Conduct and Terms and Conditions

All players must agree to the Code of Conduct. Please read and agree to the terms and conditions listed below:

a) The club reserves the right to suspend or expel from the club any player, member or supporter for failing to abide by the rules, regulations and/or code of conduct

I agree to be held personally liable for any fines incurred by the club as a result of a breach of VCFA rules by either myself, family or the player/s being registered on this form and agree to reimburse Bayswater Strikers Soccer Club for the full cost of any such fines. Any failure to pay these fines may result in expulsion from the club.

b) De-Registration/Refund Policy

Full refunds will be issued to players who cannot be registered with the club for any reason, e.g. lack of numbers. De-registration/transfer from the club/cancellation by any player will require clearance from the club. This player will forfeit the VCFA registration fees as applicable and a \$25 Office Administration fee as a minimum and will forfeit the whole player registration fee if the player has played any games.

c) Accident and Injury Disclaimer

I hereby agree that Bayswater Strikers Soccer Club including any of its officers and/or members shall not be held responsible for any accident, illness or injury sustained while playing/functions. I understand that The Club carries only public liability (provided through registration with The VCFA) and that it is my responsibility to arrange additional insurance cover. The Club will not be liable for any cost not covered by the VCFA Insurance that shall be for the account of the players. I also give my permission for Bayswater Strikers Soccer Club to arrange medical attention that may be deemed necessary including ambulance transport and I agree to pay for all such costs incurred. Bayswater Strikers Soccer Club agrees that it will do its utmost to contact emergency contacts, if possible, prior to seeking medical treatment, but I understand and accept that it may not be possible to do so in the circumstances.

d) Assistance on match days

Players, Members, Supporters will need to provide Bayswater Strikers Soccer Club with assistance on training and match days, which may include helping in the canteen and putting up nets and goals from time to time. These duties will be advised by the president, committee members or the coaches.
